Why the adjustment?

因教育部實施「促進國際生來台及留台實施計畫」，規劃5年投入新台幣52億，所以對國際生有所補助。再加上配合政府其他相關政策，所以本學院將實施調降學費。

The Ministry of Education has launched the "Implementation Plan for Promoting International Students to Come to and Stay in Taiwan" program, which involves a five-year investment of NT\$5.2 billion. As a result, international students are eligible for subsidies, and in line with the government's other policies, the International College has decided to reduce tuition fees.
